- \* Training. Only use properly trained and competent companies and installers
- \* Education of owners of the systems
- \* Inspection of installation
- \* Use modern energy efficient systems
- \* Registration of Installations
- \* Regulations

# What can manufacturers do?

- \* Only offer warranties on installations done by fully trained installers, or commissioned and inspected by themselves.
- \* Train installers
- \* Produce comprehensive and clear guides
- \* Only supply complete systems
- \* Offer Maintenance plans
- \* Keep a record of all installations

# Conclusions

- \* Water Companies should take responsibility for water quality in the house
- \* Manufacturers should ensure their product is fit for purpose and properly installed
- \* Only properly trained installers should be allowed to install/commission these systems
- \* Water reuse systems should be registered?
